Please find attached my application. In support of this application, you have requested details of how may experience and skills may be of benefit to the Parish Council.

By way of background, my parents moved to Church Cottages in Ennerdale in 1966 and I grew up here from a baby to the end of my primary education at the village school. When my Father's medical career necessitated a move to Scotland, they also bought our current home, then a semi-derelict farmhouse, in the early 70s and weekly commuted between Ennerdale and Glasgow until my parents moved back permanently. My Grandfather lived in a cottage at Bridge End where I also lived for a time some years later. Though my military career has often taken me elsewhere, Ennerdale has always been home and my wife, and I have now moved back here and started are own business together with keeping the farm.

In terms of experience, I have worked on local farms as a child and teen and now find myself fortunate enough to own a farm. Given the fundamental relationship between farming and the Parish, I would hope that I have something to offer here. My first career was as a soldier and an engineer with 35 years' service including roles ranging from hands-on engineering, to managerial and leadership appointments in combat, logistic, engineering and intelligence units.
